Sub.: Information pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI Listing Regulations”)

Ref.: Scheme of Arrangement between Siemens Limited (“Demerged Company”) and Siemens Energy India Limited (“the Company” or “Resulting Company”) and their respective shareholders and creditors under Sections 230 to 232 and other applicable provisions of the Companies Act, 2013 providing for the demerger of the Company’s Energy Business (as defined in the Scheme) to the Company, sanctioned by the Hon’ble National Company Law Tribunal, Mumbai Bench (“Scheme”)

Dear Sir / Madam,

Please note that the Company had made the following disclosure in its Information Memorandum dated June 4, 2025 stating that *inter alia* the following material civil proceedings had been transferred to the Company pursuant to the Scheme:

“In June 2020, the Energy Business of the Demerged Company was awarded a contract by Siemens Energy LLC Russia (now renamed Neftegaz & Energetika LLC) (“SE Russia”). In July 2020, the Demerged Company received an advance payment of ₹ 349.96 million¹ from SE Russia. On September 16, 2022, the Demerged Company issued a notice of force majeure to SE Russia and subsequently terminated the said contract on October 4, 2022. On March 12, 2025, the bankruptcy manager of SE Russia informed the Demerged Company that they had initiated litigation proceedings on behalf of SE Russia claiming ₹ 492.10 million¹ from the Demerged Company before the arbitration court of St. Petersburg, Russia. The matter is currently pending before the arbitration court of St. Petersburg, Russia.

In this regard, please note that the Company on July 21, 2025 at around 16.39 hrs has received the following update:

The arbitration court of St. Petersburg, Russia (“**Court**”) vide its ruling dated July 17, 2025, has declared the supply contract dated July 16, 2021, as also the advance payments made by SE Russia under the aforesaid supply contract as invalid. In view of the above findings, the Court has awarded a total amount of ₹ 443.76 million² (USD 5,165,129.62) along with additional interest @ 8% p.a. to be paid from May 30, 2025 till the date of actual payment of the principal amount.

The Company believes that the ruling is unsustainable in law and contract and hence intends to file an appeal against the same.

Kindly take the same on record.
